

The Church of Jesus Christ of
Latter Day Saints (Mormons)
has recently announced a new
updated version of their
popular program from personal
computer owners. The only
change in programs is to the
IBM and IBM-compatible
computers. The program is
called Personal Ancestral File
and is available for IBM,
IBM-Compatible, Macintosh, and
Apple II computers.

The cost of PAF for home computers is \$35. Registered users of earlier versions of MS-DOS based PAF should have received or will receive a letter explaining how they can upgrade to the new program at a reduced price.

Wealthy (Wealtha) Hatch
Carrier Wood (1st husband
Amaziah Carrier, 2nd husband
Silas Wood) came to Rice Creek
(Sheridan twp.) Calhoun Co. in
1836 with her 2nd husband
Silas Wood. They came with a
group that included her son
and daughter - Burt H. Carrier
and Polly Carrier Miller (Mrs.
David H.). Also settling at
Rice Creek in 1837 were
Younglove Monroe Hatch and his
wife Hannah Swift.

I know from my family notes that Wealthy Hatch and Younglove Monroe Hatch were related. He was either her brother or her nephew. They are both buried in Rice Creek Cemetery.

According to Biographical Review of Calhoun Co (Evert & Co. 1877), Younglove and his wife had the following children: Lorinda (Mrs. Ephraim Marble), Henry (d. in CA aged 30), James Warren, Susan M (deceased), Emerette (Mrs. Robert J Stark).

According to Biographical Review of Calhoun Co. (Hobart, Chicago 1904) James Warren Harch m. Juliette Austin, moved from Lee Twp. to Fredonia Twp. Their children included Jesse Monroe Hatch b. 27 May 1858. He became an attorney, m. Ella M Willard (dau. of Lovett J and Lucy Willard) Oct 9, 1885. Their children included: Jay Warren, Blaine Willard, Beatrice Augusta, Donald J, Louise, Hortense, Hazen.

I believe that Wealthy Hatch was the dau. of Hannah Monroe (Manrow) and Timothy Hatch of Conn. I am wondering if any one has researched this line of the Hatch family and cangive me information about its origin. I would he glad to exchange information.

The Society Chairman would be required to attend Michigan Genealogical Council meetings, reporting to the Board of Directors.

The Chairman will be responsible for the local arrangements and other responsibilities within Michigan. Most of the job. could be handled by mail or telephone, with committee meetings within Michigan. The applicant should be able to get to the three site choices of Detroit, Lansing and Grand Rapids.

Benefits would be instant recognition for the Chairperson on a National level. The pride the Chairperson will be able to take in the difference in bringing this type of education to the Michigan and Great Lakes area.
