Call to Action!

CCGS is YOUR organization and it faces a very precarious future.

This note is to encourage our CCGS membership to step forward for vacant leadership roles that affect the future of our Society.

The Calhoun County Genealogical Society was established in 1988 with four specific goals in mind:

To gather and preserve information of genealogical value

To encourage the deposit of such information in suitable depositories

To aid genealogist in the study of family history through the exchange of knowledge

To publish and promote Calhoun county and other genealogical materials

If CCGS is to continue as a viable organization, it can do so only with a diligent and engaged membership willing to make it so. Any organization is only healthy if it has enough active members.

CCGS's ongoing challenge has been to recruit and retain enough skilled and committed members to serve on its board. As board members leave, the challenge to the entire membership is clear: to step forward and take ownership of CCGS by assuming leadership roles. The following positions are currently vacant:

Recording Secretary – The Recording Secretary shall keep records of all meetings of the Society and of the Executive Board. This includes: taking minutes of monthly board meetings, the annual meeting, and any other Society meeting at which official business is conducted. The Recording Secretary also

emails minutes to board members before subsequent meetings and signs minutes after approval.

MGC Delegate and (2) Alternates – We are allowed two delegates and two alternates. The Michigan Genealogical Council meets the second Thursday at 1:00 p.m. of odd months; Jan, Mar, May, Jul, Sep & Nov at the Historical Center in Lansing. Delegates report back state-wide significant events to our membership.

Our current Vice-president, Alex VanZanten, has agreed to move from Vicepresident to President, but several additional members of the board will be forced to leave the Board due to term limitations stated in our By-laws. Those positions include:

Vice-president – serves in absence of the President and chairs the Programs and Publicity Committee, which plans programs for each meeting. Also may perform other duties as assigned by the President.

Corresponding Secretary – The Corresponding Secretary shall be responsible for all correspondence with members, other groups and individuals.

Treasurer – The Treasurer shall collect all dues and monies, attend to all disbursements and have charge of all funds of the Society. The Treasurer shall have the authority to disburse funds of the Society.

I have confidence that Alex will be excellent in his new role of President, however, it should be obvious to all that no incoming President can keep our Society running all by himself.

All Board Members are expected to attend a majority of regular and board meetings. Our board meetings are the third Thursday of

every month (except July, August and December) at 7:00 at the LDS Church, 16036 U.S. Hwy 27 N. Our regular meetings are the fourth Tuesday of every month, except July, August and December, same place and time.

Most of these positions require no genealogical skills, and less than one hour per month, in addition to the meetings. Existing board members will assist and work closely with new officers and chairs to get started with their new duties. Expenses for performing Society duties are reimbursed by the Society or can be deducted on income tax forms as volunteering for a non-profit organization (501c3) under charitable deductions. If you are new to genealogy, getting involved is a great learning experience. For those members who have been waiting for more experienced members to step forward, this message is for you. This is YOUR opportunity to step forward and revitalize CCGS with new ideas.

If you would like to discuss the responsibilities of any above positions, please contact any board member below. You are under no obligation if you call for more information. We want the Society to continue and that can only happen if we fill these positions with the right candidates. Please consider joining the CCGS board – you will find it a very rewarding experience. Thank you and I hope to hear from you in the very near future.

The following on-line Canadian records are available Free:

- * Quebec Library and Archives Canada (LAC). 1825 census of Lower Canada. Lower Canada is modern-day Quebec and this census covers some 74,000 households. This early census only lists the head of each household, their occupation and the number of family members. The database can be searched by family name, first name and keyword. Remember, only the head of the household is listed by name. http://www.bac-lac.gc.ca/eng/census/1825/Pages/1825.aspx
- * National 1901 census of Canada. This updated version includes revisions to the database that were sent in by users as well as revised district and sub-district information. The 1901 Canada census was the fourth general census of Canada (1871, 1881, 1891 and then 1901). It covered the provinces and territories then in existence: B.C., Manitoba, Ontario, Quebec, New Brunswick, Nova Scotia, Prince Edward Island and the Northwest Territories (current day Alberta, Saskatchewan, Yukon, Nunavut, etc.). The database can be searched by province, name and keyword. See http://www.bac-lac.gc.ca/eng/census/1901/Pages/1901.aspx
- * National 1871 Canadian census updated. This was the first general census of Canada. It covered the four provinces that were then part of Confederation: Ontario, Quebec, New Brunswick and Nova Scotia. This new version includes corrections sent in by users as well as revised/improved district and sub-district information. The collection can be searched by name, age, province and keyword. See http://www.bac-lac.qc.ca/eng/census/1871/Pages/1871.aspx
- * New Brunswick The New Brunswick GenWeb project has put online information on an additional 55 cemeteries in the province and provided updates on a further 16 cemeteries. The records can be searched by name and by region. See http://cemetery.canadagenweb.org/NB/
- * National Library and Archives Canada has created a special database for anyone tracing ancestors who arrived from China. The database has some 100,000 records and spans the years from 1885 to 1949. See http://www.collectionscanada.gc.ca/databases/chinese-immigrants/index-e.html
- * Prairies Library and Archives Canada (LAC) has just released a new version of the 1906 Census of the Northwest Provinces. This census covers the three prairie provinces of Alberta, Saskatchewan and Manitoba. This census has been available to search before, but it was limited to image searches by geographic region. The new database can now be searched by name, age, and keyword. See http://www.bac-lac.gc.ca/eng/census/1906/Pages/1906.aspx
